The Smarter Balanced Ecosystem Course is a new, self-paced course available at no cost to Connecticut educators. It gives educators the opportunity to learn about the Smarter Balanced system of tools and resources including:

- the **formative assessment process** and how to help students achieve their learning goals,
- the different types of **interim assessments** and how they can be used to inform instruction,
- instructional resources and strategies available in **Tools for Teachers**,
- depth of knowledge assessed by the different types of tests through the **Smarter Content Explorer** website, and
- the **summative assessments**.



The course includes videos, annotated note-taking guides, and even a scavenger hunt that challenges the user to find specific professional learning resources in the Tools for Teachers website. The course takes about two hours to complete. Participants will receive a certificate of completion after successfully passing the embedded quizzes.

2022 Connecticut SAT School Day Digital Testing Webinar Series

In the spring 2022, all grade 11 students will take the Connecticut SAT School Day using a computer instead of paper and pencil. The test will be administered on March 23-25 & 29-30, 2022, with make-ups scheduled for April 26-28, 2022. Schools can use all of these days to administer the test digitally. All students do not need to be tested on the same day.

In order to prepare staff for digital testing, a series of webinars is scheduled. All sessions are from 1:00-2:00 PM.

Attendees must register for the entire series but may attend *all or some* of the sessions. Webinars will be recorded and posted to the [CSDE's CT SAT School Day web page](#).

Accommodations and Digital Testing

Interested in getting a head start on learning more about the availability of accommodations for digital testing? The [2022 Connecticut SAT School Day Accessibility Chart](#) captures the embedded and non-embedded universal tools, accommodations, and English learner (EL) supports available for eligible students. You may notice some differences between the naming conventions of these supports and accommodations, but their functionality remains the same as on other Connecticut online statewide assessments. [Accommodations for Students with Individualized Education Programs and Section 504 Plans and Supports for English Learners: What to Expect for Digital Testing](#) explains the similarities between processes related to requesting accommodations for the Connecticut SAT School day using SSD online and new procedures related to digital testing, such as entering approved accommodations in Cambium's TIDE system prior to testing. More information will be provided on the December 6 webinar.

SSD Online Submission Window for Students with an IEP, 504 Plan or English Learners

Accommodations must be submitted through the College Board's SSD online system for students with an IEP or Section 504 Plan between **November 29, 2021, and February 2, 2022**. Requests for EL time and one-half for eligible students can be entered in SSD between **January and February 2022 (exact dates TBD)**.

SSD Coordinators are encouraged to work with appropriate staff to review their current 11th grader rosters to determine which students qualify for accommodations and EL supports, or may require updates to pre-existing accommodations approved by the College Board from former test administrations. One way to accomplish this is by printing a report of existing 11th graders with SSD accounts.

1. Authorized SSD users should log on to [SSD Online](#).
2. From the dashboard, select Grade 11 and filter by choosing "CB" accommodations in the "Type" field. Then, filter by status: in review, approved, or non-approved.
3. Right click and select print.
4. Track changes and make updates on the paper copies. When the SSD submission opens on November 29, you'll be ready to submit changes. As a reminder, if you have students that were not approved for certain accommodations on College Board assessments in the past, but qualify for them per an active IEP/504 Plan, resubmit requests for the Connecticut SAT School Day.

2021-22 Connecticut Assessment Guidelines

The new [2021-22 Assessment Guidelines](#) is now posted to the Connecticut Comprehensive Assessment Program Portal. This resource is intended to provide guidance for Connecticut educators who must make decisions about testing special student populations for the following assessments: Smarter Balanced, Next Generation Science Standards (NGSS) Assessment, Connecticut Alternate Assessment (CTAA) in English language arts and mathematics, and the Connecticut Alternate Science (CTAS) Assessment. This resource captures information related to accessibility features, designated supports, and accommodations for Connecticut's statewide testing program.

Accommodations for Students with Disabilities, Section 504 and English Learner Students

The window to submit accommodations for students with an active IEP or Section 504 Plan taking Smarter Balanced or NGSS Assessments will be from November 19, 2021- June 3, 2022. If students are taking interim assessments prior to November 19, accommodations and designated supports are manually entered by the teacher using the Test Administration Interface. Annual Online Training Available Now for Teachers Administering the Connecticut Alternate Assessments

[The Connecticut Alternate Assessment System Training](#)—Required for Teachers Administering the Alternate (TEAs) for the 2021-2022 school year is now available. The training course link, along with all other relevant training resources, can be found on the Alternate Assessment webpage located on the Connecticut Comprehensive Assessment Program Portal or by referencing this link: <https://ct.portal.cambiumast.com/en/announcements/2021/09/ct-ta-cert-course>.

As a reminder, the Data Entry Interface (DEI) opens on November 19, allowing trained TEAs to submit the Connecticut Alternate Assessment Eligibility Form. Teachers without a TEA user role or those TEAs who have not completed training will not have access to the DEI. Teachers must plan ahead complete this important training.

Clarification of IEP Page 9 for English Learners

English Language Proficiency Assessment

- English Language Proficiency Assessment required for all English Learners Grades K-12
- Student requires designated supports/accommodations on the ELP assessment

If a student is dually identified (both an English learner and a student with disabilities) in Grades K-12, the first checkbox under English Language Proficiency Assessment on page 9 should be selected. The selection of this checkbox will include students who are English Learners who are also determined eligible for participation in an alternate assessment.

The second checkbox is specifically for the English Language Proficiency Assessment, the LAS Links, for Grades K-12. If the student has an IEP, is participating in the LAS Links, and that student requires supports and accommodations, (as described in the online LAS Links Accommodations Guidelines), this second box should be selected. This will be explained in the upcoming ELAC Training and in a forthcoming communication called Assessment Procedures for Dually Identified Students for the 2021-22 School Year memo.

Dually-identified students who meet eligibility criteria to participate in the Alternate Assessment (CTAA and CTAS) using the [Alternate Assessment Eligibility Form](#) will have the first box selected indicating the English Language Proficiency Assessment is required, and will not participate in the LAS Links because it is not an appropriate assessment for this relatively small group of students.

Similarly, for dually-identified students in Grades K-2, 9, 10, and 12, if the first box is selected indicating English Language Proficiency Assessment is required, and the student is identified as potentially eligible to participate in an Alternate Assessment, they will not participate in the LAS Links. Instructions about this process will be included in the forthcoming Assessment Procedures for Dually Identified Students for the 2021-22 School Year memo.

Information Technology Contact for LAS Links

Districts are required to report an Information Technology (IT) contact who will support the LAS Links assessment. The IT Coordinator must complete a [survey](#) found in the [Supporting English Learners During the 2021-22 School Year letter](#). Once the LAS Links Lead IT Coordinator has submitted the survey, they will receive an invitation to register for one of the two LAS Links IT Webinars, which will be on November 1, 2021, at 2:00 p.m. and December 1, 2021, at 12:00 p.m.

Parent/Guardian Student Reports for LAS Links

Now available on the [Connecticut DRC LAS Links](#) website, in the Scoring and Reporting section, are letters to support communication with parents/guardians who may be receiving copies of their child's LAS Links Student Score Report from the 2021 testing session. This version of the letter has been shortened, uses more accessible vocabulary, and follows the layout of the Student Proficiency Report. It is available in the following languages: English, Arabic, Chinese (Mandarin), Haitian-Creole, Polish, Portuguese, and Spanish.

PSAT and AP Reminders from College Board

Q. What can I do for my students who were unable to take the PSAT/NMSQT this October?

A. You may test 10th graders using the PSAT 10 in February, March, or April. You may test 11th graders using SAT School Day in March or April. If you're unable to test on an official PSAT/NMSQT date in 2021, students who are eligible for National Merit Scholarship Corporation's program may reach out to them to request [alternate entry](#) into their program.

Q. When will PSAT/NMSQT score reports be available?

A. For educators, most scores will be available November 29, 2021. Scores will be available December 6 and 7 for students, depending on where they reside.

Q. How can I access PSAT/NMSQT score reports?

A. All scores will be available in the [K-12 score reporting portal](#). If you've never used the K-12 score reporting portal, your school's access manager can provide you with access. Be sure to request Detail Access to see individual student scores.

Q. When do I need to register for and order second-semester AP exam only sections?

A. All exam only sections, regardless if they start in the fall or the spring, must have orders placed by the November 15 deadline or the late order fee will be applicable.

Q. How much is the late order fee if we're unable to register students by November 15?

A. The late order fee is \$40 per exam.
